## President's Corner <br> David Sophusson

Hi All,
Due to an over-abundance of articles that need to be printed in this month's Riffle, I need to keep this short and sweet. Maintenance and repairs at the hatchery have mostly been made and ODFW has already been collecting brood stock for this year's spawning. As of now, things are looking good for another great year. I would like to shout out a great big Thank You to all the members and supporters for this great cause.

General Meeting - Oct. 11, 2012
President- David Sophusson called the meeting to order at 10:10am. The minutes of last month's meeting will be printed in the Nov. issue of The Riffle. David reported that the board had approved a motion to start reimbursing Gary Underhill \$300/mo. for his vehicle expenses. The newest 'trash' pump and all the hoses were stolen from locked buildings. A report was made to the police, a claim has been made to the insurance co. and a letter was written to the newspaper.
Treasurer's report- Mike Kopec presented the monthly report showing a gain of \$3,405.51 and an end of month balance of $\$ 26,144.15$. The successful month was due to the salmon derby.
Salmon Derby- Even though the number of participants was 55 lower than last year, the derby did very well. CAF will donate $\$ 500$ to the Sea Lion Patrol. The leftover alcohol will be used at next year's derby.
Hatchery- The locks have been changed in critical places and the keys will be selectively distributed. The vault gates have been replaced and we have some spare parts. The blocker dam is in place, the new ladder gate is ready for installation, the walkway to the vault is cleared and the hatchery is set for winter. There are 4 fish in the holding tank. Spawning will be on Tuesdays beginning Nov. $13^{\text {th }}$. The board will be discussing security cameras as a budget item for next year.
Board Members for 2013- Anyone interested in becoming a board member is asked to please talk to one of the present board members. Barbara Jorge will seek election and become the treasurer. Mike Kopec will leave the board and all other incumbents will be up for reelection. If there is a CAF member that seeks a floor nomination at the Dec. meeting, the board will announce which current board member would prefer to step down.
Christmas volunteer appreciation/election general meeting- Chris Underhill will reserve our meeting site and announce the meeting in this issue. CAF will provide the main meat entrée for the potluck dinner.

## General Meeting- Sep. 13, 2012

President- David Sophusson called the meeting to order at 10:10am. The minutes of last month's meeting were approved as printed in The Riffle.
Treasurer's report- Mike Kopec presented the monthly report with a gain of $\$ 1,258.86$ and an end of month balance of $\$ 22,738.64$. The Gold Beach Promotions Committee donated \$1,500 for the derby and became a CAF sponsor-member. The Dorothy and Eldredge Combs Memorial Fund purchased 10 sets of masks and snorkels for use at the $4-\mathrm{H}$ summer camp.
Salmon Derby- The number of participants was down to 77. The number of entrants for the Rotary and Brookings derbies was also lower this year. The total for derby expenses isn't final, but the gross proceeds are $\$ 8,678$. Mike will call for a critique meeting to evaluate changes for next year. At the STAC BBQ in Aug., Mike met the OR Distributor for Eagle Claw products who donated many Eagle Claw products for the derby raffle and other CAF fundraisers.
Hatchery- All the fish have been successfully released. There were a lot of volunteer helpers and it was a good rearing year. A short discussion ensued about the timing of future releases to reduce predation losses. The first of Oct. will be the beginning of holding spawners. Gary will take a month off and then will call for work parties. There has been a big increase in rat activity, so baiting activity needs to be increased.
ODFW - David relayed the information presented to the board by Todd Confer relating to a possible study of cormorant predation on the lower Rogue. An informal and concerned discussion about CAF involvement resulted in the following motion: Motion- presented by Gary Underhill, seconded by Philip Dickson, that CAF formally reject the ODFW offer for CAF to participate in hazing of cormorants. Motion approved.
Board Members for 2013- Anyone interested in becoming a board member is asked to please talk to one of the present board members.
Ray's Market Receipts- Ray's has restructured their Community Rewards Program and will no longer be accepting receipts. They will still donate to non-profit groups, but it will be done automatically through their All Access Rewards Card. Information will be printed in the next issue of The Riffle.

# Volunteer of the Month Profile Pat Eakle <br> Submitted by Pat Eakle 

I grew up in Pope Valley, CA (Napa County) population 300. My parents made a living dry land farming and running the family business which included a grocery store, bar \& grill, and a gas station. My mother was also the postmaster of our small town. My elementary school was a two-room schoolhouse with one teacher teaching all six grades. Junior high/high school was located in St. Helena, a full hour bus ride each way. Chores growing up for myself and four brothers included feeding livestock, stocking shelves, waiting on customers, pumping gas, cooking burgers, dicing, plowing, sowing, mowing, raking, baling hay, and even sewing sacks on a grain harvester.
I decided after high school that if I didn't want so many jobs, I should go to college. I graduated from Napa Jr. College while still helping at home and working a swing shift at Kaiser Steel in Napa. I then enrolled at Fresno State College and lived in an international housing complex. My roommates included John from Bakersfield along with two Vietnamese kids, Duy and Tuan. After three semesters, one thing led to another, and I found myself enlisting in the USMC.
Following Boot Camp and Artillery School, I was sent to the $12^{\text {th }}$ Marines in Vietnam and assigned to Headquarter Battery $2^{\text {nd }}$ Prov, a $155-$ towed battery at a fire base ten miles south of the DMZ. I was then transferred to the 11th Marines Headquarter Battery SII and assigned to a counter rocket team. Eventually, a long awaited call came over the radio, "Echo-4-echo, your ride home is coming. Get your gear." At Camp Pendleton ten days later, I got in line for early outs.
Returning home to Pope Valley, I went back to help with the family business, worked as a laborer for a construction company, and also worked as a billiard table mechanic. Again, too many jobs. I decided to finish college. Sadly, it was during this time that my former roommate, John, who had become my best friend, was killed in Vietnam. With the help of the GI Bill and working on the school farm, I graduated from Fresno State with a B.S. in Agricultural Science. My first after college employment was with a small farming company as their working manager farming cotton,
watermelons and grapes. The job included the responsibilities of payroll, employee supervision, planting, pruning, irrigating, spraying, and other farming duties. After three years I took a position as Fresno Branch manager for Dadant \& Sons, Inc., a 150 year-old beekeeping supply and manufacturing company. This position included responsibility sales, inventory control, public relations, customer service, employee supervision, as well as forklift operation and other warehouse management duties. Again, too many jobs.
Also during this time, Charlene and I farmed 40 acres of Thompson grapes while she worked full time as a high school special education teacher. Eventually, the vineyard was sold and we built a home in Shaver Lake, a small town in snow country in the Sierras about fifty miles from Fresno. After my 33 years with Dadant \& Sons and Charlene's forty years in education, we retired to Gold Beach. Here I totally enjoy my new jobs: household/yard projects of my choosing, preparing meals, entertaining grandchildren, walking the Jaz and Jed, and regularly loosing at cards to Charlene. I also enjoy the work parties at the hatchery, and especially making sure there is a quorum for the "safety meetings."
